15 I, HELEN YORK JONES, declare:

16 1. I am a food service aid at California Pacific Medical Center and a member of the
17 Executive Board of United Health Workers-West ("UHW"). I have been a member of the UHW
18 Executive Board from 2000 to present. I make this declaration based on my personal knowledge.

19 2. I attended the UHW Executive Board meeting on May 18 and 19, 2007. Attached as
20 Exhibit A, is a true and accurate copy of my notes from that Executive Board meeting. I took these
21 notes during the meeting, and they are in my handwriting.

22 3. My standard procedure is to take notes at Board meetings in a notepad provided by
23 UHW or the venue at which we are meeting. My practice is to remove the notes of meetings from the
24 notepad to take to my Steward Council meetings. Although I sometimes discard these notes after the
25 Steward Council meetings, I did not discard the note attached as Attachment A from the May 18 and
26 19, 2007 meeting.

27 4. My notes state "May, 18, 19, 2007 educate our members. . . public." This is a
28 reference to the establishment of the United Healthcare Workers and Patients Education Fund. My

1 notes also state "February 8, 2008 Healthcare Reform" and "February 20, 2008 Summit Rally." My
2 notes refreshed my recollection that at the May 18-19, 2007 meeting, these two events were
3 suggested as potential activities that the Education Fund could engage in.

4 5. I declare under penalty of perjury under the laws of the State of California that the
5 foregoing is true and correct.
